- Return of parts sold more than 6 months ago.

Please be advised that Accutite Fasteners, Inc. has and is taking immediate action to implement the controls necessary to respond to your company's reporting requirements under the Conflicts Minerals Law. Accutite Fasteners is a distributor of fasteners and does not perform any manufacturing operations. We flow down to our suppliers our customer's drawings, specifications, and the quality requirements invoked. The Accutite Fasteners Standard Terms and Conditions also cover Conflict Minerals. As of Jan 1<sup>st</sup>, 2019, we have no suppliers indicating the use of any restricted materials from the "3TG"
